Terms and Conditions

Manchester Derby Promotion

("Promotion")

1. The promoter is AxiCorp Financial Services Pty Ltd ACN: 127 606 348 ("Axi") an Australian incorporated company registered with the Australian Securities and Investments Commission, whose registered office is situated at Level 5, 126 Phillip Street, Sydney, New South Wales, Australia, ("Promoter"). 3. This Promotion commences at 00:00:00 Greenwich Mean Time ("GMT") on **20 September 2022** and ends at **23:59:59 GMT on 8 October 2022** ("Promotion Period").
4. Information on how to enter forms part of these terms and conditions ("Terms"). Participation in this Promotion is deemed acceptance of these Terms.
5. This Promotion is open to all entrants who:
 - are 18 years of age or over; and
 - are not residents of the European Union, the United States of America, Japan, Brazil, and the province of Quebec in Canada; and are not directors, management, employees, or agents of the Promoter or its related entities (or immediate family members of such persons) ("Eligible Entrant").
