Terms and Conditions

Copy Trading \$50 Trading Bonus Promo ("Promotion")

1. The promoter of this promotion is AxiTrader Limited ("**Axi**"), Suite 305, Griffith Corporate Centre, PO Box 1510, Beachmont, Kingstown, St Vincent and the Grenadines, incorporated in St Vincent and the Grenadines, number 25417 BC 2019 by the Registrar of International Business Companies, and registered by the Financial Services Authority ("**Promoter**"). 2. The partner in this Promotion is Manchester City Football Club Limited ("**Man City**"), Etihad Stadium, Etihad Campus, Manchester, M11 3FF, incorporated in the United Kingdom with company number 00040946.
3. By taking part in this Promotion you acknowledge you have received, read, and agree to be bound by these terms & conditions and the documentation available on the website <https://www.axi.com/int/legal-documentation> ("**Documentation**").
4. Defined terms have the same meaning as the Documentation unless otherwise specified in these terms & conditions.
5. This Promotion commences at 00:00:00 Greenwich Mean Time ("**GMT**") on 24 July 2022 and ends at 23:59:59 GMT on 16 September 2022 ("**Promotion Period**").
6. Information on how to enter forms part of these terms and conditions ("**Terms**"). Participation in this Promotion is deemed acceptance of these Terms.
7. This Promotion is open to all entrants who:
