As a valued Axi Partner

We want you to gain more opportunities by using our brand to help promote and build your business.

We offer leveraged products that are considered complex and high-risk. We therefore expect all our affiliate partners to demonstrate a level of responsibility in their marketing. It's very important that you don't deliberately mislead anyone or mispresent Axi by infringing our intellectual property rights or impersonating our brand in a way that could cause confusion for consumers.



General Rule

Affiliates are only permitted to use the official Axi marketing tools found in the Marketing Tools section of your AxiAffiliate account.

All your promotional content must be clear, fair and not misleading and it must comply with all associated requirements mentioned in Axi's Affiliate Marketing Guidelines.

Are you ready to start advertising?

First, make sure that you take the following into account.

- ✓ Inform your Account Manager of all the websites, platforms (Google, Facebook, etc) and regions that will be used in your affiliate strategy.
- ✓ Do not use unqualified, absolute statements or unwarranted claims – always seek to use balanced statements.
- ✓ Note that CFDs are the only products that Axi offers. We are not authorised to offer Binary Options.

Making statements

The products that Axi offers are high risk leveraged products and all statements must be balanced.

For example, if you mention potential profits, you must also mention potential losses. All financial promotions on a website that promotes Axi must have an appropriate risk warning such as "Losses can exceed deposits" or "CFDs are high-risk leveraged products"



CFDs

Axi offers trading in CFDs only – always make sure this is clear.



Phrases including "trade the stock market", "access to the stock market" and "stock broker" are not acceptable.

Axi does not offer these services or trading by accessing the stock markets and it is, therefore, misleading to make promotions in this context.

When using the words "bourse", "stock exchange" or "stock market", you must make clear that you're referring to trading "with/using CFDs", as applicable.

The word "Free"

Be cautious about using the word "free".

"Free" can be used in relation to the demo trading mode, the software, the platform, charts and quotes. The word "free" cannot be used in relation to trading or the risk of trading.

- ✗ Give trading advice to clients or followers

In certain countries like the UK for example,

Financial success

When advertising Axi, do not make unwarranted claims of financial success by traders and do not promise guaranteed profits.



Do not use "earn" or "win"

Avoid using images that suggest a lavish lifestyle brought by CFD trading such as piles of money, expensive cars and objects or images that suggest soaring prices and a price rally.

Do not use the word "play", even when the advertisement/promotional material is related to demo mode/practice mode.

the word 'play' implies that our services, even the demo service, are like a game. Don't use "Gamble on stocks" or "Money game".
