



## **ADDENDUM**

### **Additional Terms**

#### **1. Minimum activity requirements (CPA payment threshold)**

- Minimum 5 qualified NTCs per month
- Minimum USD 2,000 in generated CPA commissions

#### **2. ROI and payment conditions**

a) ROI is calculated as: total net deposits of referred clients ÷ total commissions generated by the affiliate for that month

b) Minimum ROI of 1.5 is required from the first month, and 2.0 from the sixth month onwards

c) If ROI is below 1.0 in any of the first two months, payments are deferred to the next month, contingent on achieving an average ROI of 1.5 over the two-month period

d) If ROI remains below 1.5 by the third month, Axi reserves the right to terminate the agreement without payment.

e) If a client withdraws at least 60% of his initial deposit in the first 60 days since that deposit, then the CPA commission for that client is void

#### **3. Country tiers**

Tier 1 includes

- Austria, Belgium, Canada, Denmark, Finland, France, Germany, Guernsey, Iceland, Isle of Man, Jersey, Ireland, Italy, Liechtenstein, Luxembourg, Netherlands, Norway, Puerto Rico, Singapore, Spain, Sweden, Switzerland, UAE, United Kingdom

Tier 2 includes

- Rest of European Union: Bulgaria, Croatia, Czech Republic, Estonia, Greece, Hungary, Latvia, Lithuania, Malta, Poland, Portugal, Romania, Slovakia, Slovenia
- GCC: Qatar, Kuwait, Saudi Arabia, Oman, Bahrain
- Latin America and the Caribbean: Anguilla, Antigua and Barbuda, Aruba, Bahamas, Barbados, British Virgin Islands, Cayman Islands, Curaçao, Dominica, Dominican Republic, French Guiana, Grenada, Guadeloupe, Jamaica, Martinique, Montserrat, Saint Kitts and Nevis, Saint Lucia, Saint Maarten, Trinidad and Tobago, Turks and Caicos Islands
- Africa: Morocco, Ghana, Kenya, Nigeria, South Africa, Tanzania, Zimbabwe
- Asia: Indonesia, Laos, Malaysia, Philippines, Thailand, Vietnam, South Korea, Taiwan, China, Hong Kong

Tier 3 includes

- All other countries (excluding banned countries)

#### 4. Monthly Affiliate Bonus Table

Affiliate Monthly Bonus		
Monthly Qualified Accounts	Bonus	ROI
30 - 49	\$3,000 USD	3
50 - 99	\$10,000 USD	3
100+	\$20,000 USD	3

- The monthly bonus is calculated based on performance during the calendar month.
- The monthly bonus is paid after the regular Affiliate commissions within 20 days following the end of each month.
- If the ROI is below the required threshold, bonus eligibility may be reviewed or deferred based on program guidelines
- The Monthly Affiliate bonus is available only to Affiliates on a Standard CPA commission.

This Addendum shall apply to all Affiliates and Hybrid Partners, unless otherwise agreed in writing between the Parties
