This is valid on any deposit that meets the minimum requirement throughout the promotion period, up to the maximum allowed amount. Internal transfers are not counted as deposits.</p> <p>If you withdraw funds, including profits, before the end of the promotion period, the trading credits will be removed. Once you redeposit and make a trade, credits will be added back. Trading credits will be removed from participating trading accounts 180 days after addition to the account. If you withdraw before the end of the trading credit expiry, the trading credit will be removed. Note also that the removal of the trading credit could result in the closure of some or all of your trades if you do not maintain sufficient funds. Internal transfers are also considered withdrawals.</p> <p>If your Axi Account Equity balance falls below the credit balance, the credits will be removed, and your open trades will be closed.
