## Terms and Conditions

### Axi x Man City Competition (“Competition”)

1. The promoter of this Competition is AxiTrader Limited (“**Axi**”), Suite 305, Griffith Corporate Centre, PO Box 1510, Beachmont, Kingstown, St Vincent and the Grenadines, incorporated in St Vincent and the Grenadines, number 25417 BC 2019 by the Registrar of International Business Companies, and registered by the Financial Services Authority (“**Promoter**”). 2. The partner in this Competition is Manchester City Football Club Limited (“**Man City**”), Etihad Stadium, Etihad Campus, Manchester, M11 3FF, incorporated in the United Kingdom with company number 00040946.
3. This Competition commences at 00:00 Greenwich Mean Time (“**GMT**”) on 1 July 2022 and ends at 12:00 GMT on 31 July 2022 (“**Competition Period**”).
4. Information on how to enter forms part of these terms and conditions (“**Terms**”). Participation in this Competition is deemed acceptance of these Terms.
5. This Competition is open to all entrants who:
  - a. are 18 years of age or over;
  - b. comply with these Terms;
  - c. are residents of The Philippines & Indonesia only; and
  - d. are not directors, management, employees, or agents of the Promoter or its related entities (or immediate family members of such persons) (“**Eligible Entrant**”).
